ANNOUNCEMENTS

IEA ANNUAL COUNCIL MEETING

On October 18th and 19th representatives of the federated and affiliated societies that make up the governing body of the IEA met for the annual Council meeting. The meeting was hosted by the Chilean Ergonomics Society, SOCHERGO, and the network of South American ergonomics societies, ULAERGO, who held a combined congress immediately afterward with the theme Inclusion and Diversity. The Council meeting was a hybrid event allowing the members who were not able to participate in person to participate online.

During the meeting the decision was made to accept two new federated societies to the IEA family, the Bulgarian Association for Ergonomics and Human Factors and the Ergonomics and Workplace Management Society of Romania. A series of workshops were held to discuss issues of common interest so that experiences could be exchanged and ideas for future activities developed. The themes included membership acquisition and support of early career members, society development strategies, and promoting education programs.

The IEA Council also approved an update to the IEA logo which will be part of the corporate image development. The executive committee thanks all of those who contributed to a very successful meeting and was very pleased with the participation and enthusiasm of so many people from a region that often is not able to participate with large numbers of representatives.



IEA2024 CALL FOR PAPERS

Have you started working on your abstracts and preparing for the IEA 2024 triennial conference that will take place in Korea from 25-29 August 2024? Abstract submissions from researchers, academics, practitioners, and professionals from around the world are still welcome. Submissions that were received before the 31st of October 2023 will receive a decision by November 30th, 2023. Papers submitted later will receive a decision by the 15th of March 2024. Optional full paper submissions must be submitted before the 15th of April 2024. This conference, which is one of the largest gatherings of HFE professionals and stakeholders globally, provides an opportunity to network and learn about some of the HFE advances being made around the world. - <u>IEA Triennial Outstanding Educators Award</u> for individuals who have made outstanding contributions to human factors/ergonomics education for having:



- Developed ergonomics education programs.
- o Produced new methodology and/or materials for teaching ergonomics.
- Graduated persons who have become outstanding ergonomists.
- <u>IEA Award for Promotion of Ergonomics in Developing Countries</u> for individuals who have made outstanding contributions to the development of infrastructure of human factors/ergonomics in an industrially developing country.
- <u>IEA Triennial Ergonomics Development Award</u> for an individual(s) who has had an international impact on human factors/ergonomics in terms of contributing or development that:
 - Significantly advances the state of the art of an existing HF/E sub-specialty.
 - Opens a new area of HF/E research and/or application.
- <u>IEA Human Factors/Ergonomics Prize</u> for a group, institution, or organization that has made significant contributions to research and development, and/or application of knowledge generally in the field of human factors/ergonomics.
- <u>The IEA President's Award</u> is for persons who have made outstanding contributions to human factors/ergonomics or the furthering of human factors/ergonomics, and whose contribution does not fall into one of the other award categories.

PERUVIAN SOCIETY OF ERGONOMICS (SOPERGO)

The Peruvian Society of Ergonomics (SOPERGO) was founded on the 14th of April 2004 as a nonprofit association comprised of multidisciplinary professionals committed to



improving working conditions in Perú. SOPERGO is not only a federated society of the IEA, but is also a member of the Latin American Ergonomics Union (ULAERGO: http://www.ulaergo.com/Quienes_somos.php).

While there are 72 SOPERGO members, it is estimated that there are approximately 500 academically trained ergonomists in Peru. Many of them have academic backgrounds from both Peru and abroad, with diplomas, master's degrees, and doctorates. One of the challenges for the current SOPERGO board is to establish a certification process for Peruvian HFE professionals to standardise and regulate HFE competencies in Peru. This would be necessary to ensure that HFE professionals stay at the forefront of high-quality HFE concepts and practices.

Ergonomics in Perú began to gain significance following the introduction of RM 375-2008-MINTRA, which requires companies nationwide to maintain basic ergonomics records. Additional legal requirements for managing ergonomic risks are provided in Law 29783, the Occupational Safety and Health Law, which mandates companies to conduct occupational monitoring regarding HFE and psychosocial factors. While implementing HFE is a legal obligation, it is worth noting that most transnational companies in mining, fishing, and formal sectors implement HFE programs while this is less common in smaller businesses.

SOPERGO has identified a commonly occurring challenge experienced by other IEA societies globally, that of improving the awareness of HFE given the high percentage of informal labour and the general population's lack of awareness about workplace safety and health issues. SOPERGO understands that widespread implementation of HFE will continue to be a challenge if HFE awareness is not improved. It is for this reason that SOPERGO engages in various awareness-raising activities. To facilitate access to some of the awareness-raising activities, SOPERGO does not charge entrance fees to attendees.
