Policy on the Support of Conferences in Ergonomics

It is the policy of the International Ergonomics Association (IEA) to support international conferences organized by any of its Federated Societies or by other international bodies that have an interest in ergonomics or that are organizing a conference with a major ergonomics theme. Support will be given for conferences of three main types: (1) congresses, (2) joint conferences, and (3) approved conferences. Meetings will normally be organized by a Federated Society or by Societies representing the IEA in cooperation with other bodies as may be appropriate.

Congress of the International Ergonomics Association

The triennial congress of the International Ergonomics Association (Congress) is the primary conference activity of the IEA. When a site for a Congress is approved, the IEA will give the organizers of the Congress all reasonable support. Support includes financial assistance at a level to be determined by the Council of the IEA. In addition, one or more representatives appointed by the IEA Council will participate actively in the organization of the Conference. The officers of the IEA and the representative(s) of the IEA Council will hold periodic consultations with the organizers and provide advice on finance, physical requirements, Congress organization, themes, topics, scientific speakers and other matters.

The IEA Council will decide the venue of the Congress on the basis of invitations received at or before the Congress immediately prior to the proposed Congress, that is, approximately 3 years before the date of the proposed Congress. The IEA Council may invite Societies to submit a formal request to the Council for its consideration.

To qualify for consideration the proposed Congress must meet the following requirements:

Submission of request

The request must be formally submitted on or before the due date (see above) by the governing body of a Federated Society of the IEA. The proposed Congress will be formally entitled the Xth Congress of the International Ergonomics Association where X is the appropriate cardinal number.

Scope of Congress

The proposed Congress must be international and intercontinental in its scope. In particular, theme speakers must be drawn from different national and continental backgrounds.

<u>Attendance</u>

There must be no restriction on the attendance of delegates, members and visitors to the Congress by reason of national origin or political belief.

Financial Support

SENTLY:

The society sponsoring the proposed Congress must be both willing and able to provide a substantial portion of the cost of organizing the Congress. The remainder, to a total to be determined by Council for each Congress, will be provided by the IEA. Any surplus remaining after the payment of all Congress costs (including all loans to the organizing society and the IEA) will normally be divided equally between the sponsoring society and the IEA. Expenses of the IEA members of the Congress organizing Committee will be the responsibility of the IEA.

ED TO: THE SOCIETY SPONSORING THE PROPOSED CONGRESS MUST CARRY THE FINANCIAL RESPONSIBILITY FOR THE CONGRESS. THE IEA MAY PROVIDE A FINANCIAL ADVANCE TO THE ORGANIZING COMMITTEE. THE AMOUNT TO BE DETERMINED BY COUNCIL. THE RETURN TO IEA WILL BE THE FINANCIAL ADVANCE PLUS 50 SWISS FRANCS PER CONGRESS REGISTRANT. EXPENSES OF THE IEA COUNCIL APPOINTED REPRESENTATIVES ON THE ORGANIZING COMMITTEE WILL BE THE RESPONSIBILITY OF THE IEA.

Location of Congress

The location of the proposed Congress should meet the following criteria:

Site. The geographical site should be at, or close to, a major center, noted for its academic and/or professional affiliations as well as for its social and historical attractions.

Congress center. The Congress center should be in one building, in which can be found administrative and logistic facilities, a major hall or auditorium for plenary sessions, conference rooms for lesser sessions, committee rooms, and suitable places for casual informal discussion with easy access to a continuous service of light refreshments. Ideally the Congress should have sole occupancy of the center or at least that part of the center in which the Congress is housed.

Translation. Facilities must be available for simultaneous translation of plenary sessions and the General Assembly into at least English, French, and German, as required by individual attendees. Translation must be available in the same conference room as the original presentation.

Accommodations. Accommodations must be available at or close to the Congress center. Accommodations should be of good quality, in terms of that normally found in the area. Different levels of accommodation should be available to meet different budgets; allowance should be made for single, double or multiple occupancy as preferred. Where it is not possible to arrange for accommodations within reasonable walking distance from the Congress center free transportation should be available at frequent intervals during the day.

Program. The sponsoring society must ensure that during the 4-5 day period of the Congress provision is made for a combination of superior quality technical sessions, both plenary and special interest, professional visits and social events. The speakers at the plenary sessions will be selected with the advice of Council, will be of international standing or of other high repute, and in total will represent the international representation of ergonomics. Themes and topics must have the approval of the Council. Provision should be made for a meeting of the General Assembly of the Association and for other meetings if requested by Federated Societies. The success of an international conference depends not only on formal presentations but on facilities for interpersonal contact and the interchange of ideas and views by discussion both formal and informal. In addition to ensuring that space is available for informal discussions, time should be allowed in the program for the exchange of ideas and views.

Transportation. Arrangements must be made by the sponsoring society for the provision of transportation to and from all events authorized by the Congress. It is especially important that adequate transport be provided between the local airport, and rail or bus stations and the Congress location or that delegates be aware in advance of the public transport facilities available. Consideration should be given to having an information desk at the airport and station or to providing full details of the Congress to the normal information agencies.

Registration, Promotion, Publication

The sponsoring society must ensure that arrangements are made for pre-registration, registration, promotion and advertising, the publication of proceedings, and the preparation of a list giving the full addresses of attendees. The IEA will assist in promotion and advertising. All promotional material and publications must state that the Congress is a function of the IEA. Following the Congress the organizers should submit a report to the IEA for the benefit of later conference organizers giving information on such things as the organization of the Congress, problems that had to be overcome, and unusual or outstanding difficulties encountered.

Joint Conference

A Joint Conference is a secondary activity of the IEA. The term is applied to an international conference in ergonomics organized by a Federated Society of the IEA, jointly by one or more such societies, or in cooperation with a cognate international organization. The IEA will provide support in the form of active promotion and advertising as well as advice and counsel on such matters as physical requirements, conference organization, themes, topics and suggestions for speakers. The IEA may or may not provide financial support and it may participate directly or formally in the organization of the conference.

NGED TO: A JOINT CONFERENCE IS A SECONDARY ACTIVITY OF THE IEA. THE TERM IS APPLIED TO AN INTERNATIONAL CONFERENCE IN ERGONOMICS ORGANIZED BY A FEDERATED SOCIETY OF THE IEA, JOINTLY BY ONE OR MORE SUCH SOCIETIES, OR IN COOPERATION WITH A COGNATE INTERNATIONAL ORGANIZATION. THE IEA WILL PROVIDE SUPPORT IN THE FORM OF ACTIVE PROMOTION AND ADVERTISING AS WELL AS ADVICE AND COUNSEL ON SUCH MATTERS AS PHYSICAL REQUIREMENTS, CONFERENCE ORGANIZATION. THEMES, TOPICS AND SUGGESTIONS FOR SPEAKERS.

To qualify for consideration a proposed conference must meet the following requirements:

Submission of Request

The request must be formally submitted to the Council of the IEA by the governing body or bodies of a Federated Society or Societies or by an international organization in an allied field for consideration at a Council or Executive Committee meeting held at least 12 months before the proposed date of the Conference. Alternatively, the IEA may itself invite a Federated Society or other international group to organize a joint meeting. Normally, either the IEA or a Federated Society will take an active role in the organization of any conference where the main sponsor is an outside organization.

Scope of the Conference

The Conference must be substantial and international in scope with speakers of international or high repute. It may be on a topic of interest to only a part of the total body of ergonomists or even on a topic of main interest to non-ergonomists but to which ergonomists are expected to make a major contribution.

Attendance

Attendance at some Conferences may be restricted because of limited facilities, or because the Conference is dedicated to an ergonomic topic primarily of interest to specialists. Nonetheless, Conferences must be open to all professionally qualified members of Federated Societies who wish to attend. There must be no restriction on the attendance of delegates, members or visitors by reason of national origin or political belief.

Promotion and Publication

All promotional material and publications must state that the conference is a joint conference sponsored by the IEA.

Program

Themes and topics must have the approval of Council.

Approved Conference

An approved Conference is a tertiary activity of the IEA. The term is normally applied to a Conference in ergonomics presented by a Federated Society of the IEA, jointly by one or more such Societies, or by another international body associated with ergonomics whose organizers wish to draw public attention to its international affiliations.

To qualify for consideration a proposed Conference must be substantial, with speakers of academic or professional repute. The request for approval must be made to the IEA Council sufficiently in advance of the proposed date of the Conference to allow approval to be given. Themes and topics must have the approval of Council.

In a region where there is no Federated Society or branch of a Federated Society, or where support from some externally located Federated Society cannot be secured, the IEA may approve a Conference in ergonomics, provided that the Conference is organized by a suitably qualified person and provided there is no objection from any Federated Society which would otherwise, as deemed by Council, have a legitimate interest in that region. A suitably qualified person will be so designated by Council and will normally be a member of a Federated Society

Conference Cooperation

The IEA may cooperate in the promotion and/or presentation of a conference by some other professional or academic association when it is deemed by the Council to be in its interests to do so. In such circumstances, at no financial cost to the IEA, the conference organizers would be permitted to use the good offices of the IEA in advertising the conference, and in particular to use the name of the IEA in promotional and other literature and to identify the IEA as a supporter of the conference. In return, promotional opportunities and/or other incentives such as reduced cost of registration for IEA members of the conference may be provided to the IEA. Reciprocal arrangements may also be pursued in which a reputable academic or professional association is encouraged to participate in the promotion of an IEA Conference or Congress.

FINANCIAL REPORTS OF ANY IEA SUPPORTED CONFERENCE SHALL BE COM-PLETED AND FILED WITH THE TREASURER OF IEA WITHIN 4 MONTHS AFTER THE CONFERENCE. ANY RETURN TO IEA SHALL BE PROVIDED AT THAT TIME.

Thank you for your letter of 30 September and for the invitation to attend the forthcoming IEA Council Meeting in Turin.

Unfortunately, it will not be possible for my Department to be represented at this meeting, but we would be grateful to you if you could keep us informed of decisions taken at this meeting. Concerning the proposed ILO/IEA International Symposium on Ergonomics in Developing Countries, I am sorry to report that no final decision has yet been taken as to the country in which the meeting will be held. However, on the occasion of my recent mission to Tunis, I had the opportunity of raising the matter with the Tunisian authorities which showed great interest in inviting the ILO and other co-sponsors of the meeting to hold it in Tunis. The Tunisian authorities hope to be in a position to make an official offer next November. Professor Wisner, with whom I had a telephone conversation yesterday, will be in a position to give you more details concerning my discussions in Tunis.

I sincerely hope that after so many delays we shall soon be in a position to start preparing seriously the International Symposium and fixing a date for the preparatory Committee early in 1984.

PRO MEMORANDUM

ERGONOMICS FOR DEVELOPING COUNTRIES: AN INTERNATIONAL CONGRESS

To: IEA Executive Committee meeting in London, March 1983.

Background

The congress Ergonomics for Developing Countries is the first of its kind (organized as a joint effort of ILO and IEA). It should be considered the start of new activities and not single event. A successful and useful congress germinates other activities and events. However, we are now faced with some difficulties to be overcome:

- Compared to ordinary scientific conferences, a greater percentage than usual of the participants do not habitually attend conferences. This implies that the organization must be effective and language barriers must be overcome. Unfortunately, these factors are partly out of our control.
- Well-prepared conference material can be a valuable source of information for the participants both during and after the conference. The quality of IEA may be able to contribute to this point. Some of the possible means are outlined in the following:
 - * the selection of well-briefed rapporteurs;
 - * the effective gathering of the texts at the conference site, possibly the recording and transcription of the talks;
 - * effective chairpersons, written summaries
 - * the effective collection of texts beforehand;
 - * an effective form of publication.

Efforts should be directed to find distribution channels which could ensure maximum coverage also outside the usual channels of ILO.

My personal opinion is that IEA should direct its effort primarily to the effective publication and distribution of the material, produced by conference or which can be produced on the basis of the conference material.

Questions to be discussed at the IEA Executive Committee Meeting

- 1. Mode and extent of participation of IEA in the congress preparations:
 - meetings of the conference committee only?
 - adopting partial tasks in the preparatuon; boundaries ?
 - a secretary to ILO for preparations of the conference ?
- 2. Preliminary tasks before the meeting of the official conference committee

Only limited time is available. As many tasks as possible should still be done before the first meeting of the official conference committee.


- Participation of the IEA federated societies in the preparations: financial support for participants from developing countries, information channels, etc.
- Locating key people to act as contact persons, chairpersons, to do preparatory work, etc.
- Preliminary program outline
 - + topics and ideas from developing countries

- 3. Contacts in the recipient country

RULES OF THE INTERNATIONAL ERGONOMICS ASSOCIATION

Name and Registered Headquarters

Under the name "International Ergonomics Association," an international organization having its registered headquarters at Zurich is formed pursuant to Article 60 et seq of the Swiss Civil Code.

Objects

The International Ergonomics Association is intended to bring together organizations and persons concerned with ergonomics or human factors, i.e., relations between the individual and his/her occupation, equipment, and environment in the widest sense, including work, play, leisure, home, and travel situations. To further these aims, it will establish international contacts amongst those acting in this field, promote knowledge and practice of ergonomics on an international basis, especially in areas where no Federated Society exists, cooperate with international associations in order to encourage the practical application of ergonomics in industry and other areas, and promote scientific research and teaching by qualified persons in this field.

Membership

The association will have a membership comprising:

- Federated Ergonomics Societies.
- 2. Affiliated Societies
- 3. Associated Societies.
- 4. Sustaining Members.

Definition of Members

- 1. Federated Ergonomics Societies will be societies that have the main aim of promoting ergonomics. They will be bodies that elect a governing council from within their own membership and encourage the free publication of research material. In general, there will be only one Federated Society in any geographical area.
- 2. Affiliated Societies will be other societies that have an interest in ergonomics but that have their main aim in an associated area or are ineligible for Federated Member status because there is already a Federated Society for their area.
- 3. Associated Societies will be groups and organizations that have an interest in ergonomics and that are international in nature. The conditions of their acceptance will be determined in each individual case.
- 4. Sustaining Members will be organizations that have an interest in the association and support it by the payment of an annual subscription.

Governing Body

The governing body of the association will be the Council. This will be made up of the officers of the association and the representatives of Federated Societies. Each society with more than 50 but less than 500 voting members will nominate one member of Council,

and those with 500 or more will nominate two. Those with 1000 or more will nominate three.

All major decisions concerning the association, including rule changes, will be taken by Council, which should meet annually. Where voting is necessary, a simple majority of those present, but not less than one-third of the Council membership is required. Postal and proxy votes will be held if necessary on major decisions where representative members are unable to attend meetings. Council members will be able to send alternative representatives to meetings from within their National Society if they are unable to attend. Council will normally be called together at the President's request or at the request of a simple majority of the members. Council will elect all new members of the association in any category.

Officers

The Council will elect officers of the association. These will be the President, Vice President, Secretary General, Treasurer, and the Chairman of the Congress Committee. The latter will be elected in cooperation with the Federated Society, which will be responsible for the next congress.

Terms of Office

Periods of office will normally commence with the Triennial International Congress. The President will serve for one term of 3 years (in addition to any period as an ordinary member of the Council). The Vice President, Secretary and Treasurer may serve for a maximum of two consecutive terms—a total of 6 years (in addition to any period as an ordinary member of the Council). Each representative member of Council will serve initially for one term of 3 years but will be eligible for re-election for one more term.

Executive Committee

An Executive Committee will be formed consisting of the President, Vice President, Secretary General, Treasurer, and Chairman of the Congress Committee. Others may be invited to attend.

All representative members of Council will be notified of Executive Committee meetings and will be able to attend if they wish. The Executive Committee will have the responsibility of making routine decisions and of carrying out other duties as delegated to them by the Council. The Executive Committee will meet at periods dictated by the needs of the association.

Finance

Each Federated Society will pay a fee consisting of a fixed amount per society, together with a variable amount based on the total number of voting members in the society at a rate to be determined by Council for each 3-year period. This money is to be used for the payment of the general administrative costs of running the association, setting up meetings, sponsoring publicity, payment of expenses of officers, and in aiding cooperation with other international organizations. Traveling expenses of the representatives of Federated Societies on Council will normally be the responsibility of that society or the individual Council member.

Auditors

The selection of the auditors will be the responsibility of the Council.

General Assembly

At each triennial International Congress, a general assembly will be held that will be a meeting open to all members who wish to attend for the purpose of receiving the approved report of the association. It will provide an opportunity for the Council of the International Ergonomics Association to hear the views of the many individual members of the Federated, Affiliated, and Associated Societies and that of the Council. It will not be a decision-making body.
