

Minutes of the 2021 Council Meeting of the International Ergonomics Association

The IEA Council meeting was virtually via Zoom during 11 and 12 June 2021.

An email ballot was conducted prior to the meeting according to the Bylaws of IEA. The Council balloting satisfied the quorum requirements.

Resolutions taken at the virtual IEA Council Meeting 12 June 2021.

Establishment of quorum: by means of a roll call, the quorum of voting members present was established as follows: 50 votes present, 8 proxy votes present, 2 officer votes present, for a total of 60 votes. Quorum for regular voting is 23 votes for non-bylaw-related items and 47 for bylaw-related items. Therefore a quorum was established.
