# President's Newsletter No. 10 June 30, 2011

#### **Dear IEA Council Members:**

The year is flying by quickly since we had our IEA Council meeting in Grahamstown, South Africa. It was great to see so many of the Council Members attend the meeting and support the activities of the Ergonomics Society of South Africa (ESSA) and the Human Factors in Organizational Design and Management (ODAM) conference. We are grateful to ESSA and the organizers of the conference for their warm hospitality and support for our meeting.

A lot has been happening since the conference and I wanted to let you know about the exciting events that have been going on as we move on to our Triennial Congress – IEA 2012 - in Recife Brazil.

#### **IEA Events**

#### **IEA Council Meeting**

The 2011 Council Meeting was held at Rhodes University in Grahamstown, South Africa with 29 council members from 18 federated societies, one affiliated society and two networks in attendance. Proxy votes were held for six societies who were not able to be present at the meeting. We appreciate the great effort and distance that people traveled to attend the meeting. While there were many important reports and discussions, I would like to highlight a few items. You can find all the details in the Secretary General's Report of Minutes, which will be released soon after this newsletter.

IEA Rules. Council agreed in principle that we should undertake a restructuring of the IEA Rules to allow for smoother administration and transparency. David Caple will head up a committee that will restructure the Rules to achieve several goals. First, Separate the Rules (by-laws) from Operation Rules (ORs), which will allow greater flexibility for future Executives to change procedures as required. Second, update the Rules and ORs to reflect the changes previously voted on by council (e.g., Vice President titles). Third, include changes that will allow the IEA to qualify for taxexempt status under Swiss law. David's committee will send their draft to a review committee for comment. Once the drafting and review committees have an acceptable draft, we will send this out to all members. Please review this with your constituents and have comments prepared before coming to the Council meeting in Recife. Please come prepared to vote on the changes at the Council meeting in February 2012. This is an important administrative matter.

IDC Support at IEA2012. We used part of the afternoon on the first day to get Council's input on different criteria that may be used for determining support for attendees from IDCs. The small group discussion generated a wide range of ideas for supporting people to attend. This input from council members is valued and important to how we function as an organization.

Future of Ergonomics. Jan Dul and Bas van der Doelen, who are spearheading the Future of Ergonomics Committee, used the second afternoon to get council members' input on: a) definition of strategies/goals and core values in 5-10 years; and b) growing and developing the demand for core values for external stakeholders. The council meeting was one of many samples that this team will draw from to come up with one view of the future of our field. This is an important project for the IEA to begin a discussion about charting the future of our field. Council's time and input were very much appreciated.

### **Opening nominations for IEA officers.**

On April 3, 2011 the council was notified that the IEA is receiving nominations for officers (President, Vice President Secretary General, and Vice President Treasurer) for the 18<sup>th</sup> Executive. Formal written nominations and candidate statements should be sent to the Secretary General 60 days before the triennial meeting (December 14, 2011). We encourage all federated societies to contribute to the future leadership of the IEA, preferably by **December 1, 2011**.

## Opening nominations for IEA 2018 Triennial Congress.

On April 2, 2011, the council was notified that IEA is receiving bids for the IEA 2018 Triennial Congress. This bid should be received by October 15, 2011, which will allow a review committee to determine the suitable possible venues. Federated societies and voting members will receive this packet of proposals by January 2012. Council will hear brief presentations by each of the candidate sites and vote at the council meeting in Recife in 2012.

## WHO Meeting in Oslo

EC member Ralph Bruder, IEA Reprehensive to WHO Wendy Macdonald, and Owen Evans attended the WHO Planning Committee Meeting Collaborating Centres for Occupational Health in Oslo, Norway on 16-17 June 2011. IEA had been invited to this meeting in our capacity as an officially recognized non-governmental organization (NGO). The larger context of this meeting is WHOs Global Plan of Action (GPA) on Workers Health (2007-2017). WHO Collaborating Centres for Occupational Health contribute to the GPA according to a global workplan on occupational health. This workplan includes objectives "to protect and promote health at the workplace (GPA objective 2)", or "to incorporate workers' health into non-health policies and projects (GPA objective 5)". Recent developments in the current workplan (2009-2012) for the Collaborating Centres were presented and plans for the new workplan (2012-2017) were also discussed.

IEA has contributed to the workplan with the development of a tool kit for the prevention of work-related musculoskeletal disorders. The work on the tool kit is coordinated by the TC Musculoskeletal Disorders (contact: Enrico Occhipinti and Wendy Macdonald).

Popular with students, he was celebrated for an annual lecture on Human Factors Engineering given to the whole first year engineering class in Convocation Hall. Professor Foley is another great leader we will miss.

# **IEA Future of Ergonomics Committee**

In December 2010 the IEA established an ad hoc Future of Ergonomics Committee (FEC), chaired by Jan Dul. The goal of the committee is to formulate a position paper on strategies toward the future of the ergonomics discipline. The paper will present the view of the committee based on individual experiences, intensive discussions, and a wide range of inputs from people inside and outside the ergonomics discipline worldwide. Organizations (including the IEA) and individuals can use this viewpoint to rethink their strategies, tactics and operations to prepare for the future.

The FEC organized a startup meeting in Amsterdam last March. The approach and first results were reported to Council at our meeting in South Africa. Council members were challenged to brainstorm about possible strategies to create an external demand for "good" ergonomics. Next steps were made by the FEC during a meeting in Paris the second week of June. Currently a green position paper is being drafted, which will be open for inputs from ergonomists worldwide. You are kindly encouraged to participate in that process. # Japanese Colleagues Survive Disaster and Contribute to Recovery

Presidents Saito, from the Japanese Ergonomics Society (JES) and Maie, from the Human Ergology Society (HES), report that all their members are confirmed to be safe and none were directly affected. Of course the tsunami and events at the nuclear power station in Japan affected many people in many ways. But it is good to know that members of the IEA family are safe.

Despite the hardships, our colleagues in Japan continue to contribute and take positive actions. Though most of the information is in Japanese language, it is good to know that our colleagues are informing the public about ergonomics and contributing to our common interests. Examples include the following:

- 1. HES continues their work on "Ergonomic Checkpoints for Human Care Work" under the leadership of Kazutaka Kogi and the working group, which met in December and January and is completing action phases. The project is scheduled to be completed in November and we look forward to seeing this 60-item checklist.

# **Organizing Ph.D. Students in Ergonomics**

I received an exciting note from François Palaci and Vincent Boccara, Presidents of the Association of French Ph.D. Students in Ergonomics (RJCE). The RJCE was founded in 2008 and currently has about 50 members. RJCE goals are to: 1) provide a structure allowing young researchers in ergonomics to exchange theoretical and practical knowledge; 2) promote the interests of PhD Students in Ergonomics; and 3) promote the development of research, teaching, and practice in Ergonomics. Current projects include:

- 1. Organizing one-day symposium on ergonomics and design, and on methods of collective activity
- Making a movie about ergonomics (the movie will be broadcast at the next Congress of SELF, which is a financial contributor to the project)
- Indentifying education programs involving ergonomics in France (with a focus on practice or on research), in collaboration with CE2 (Association of French lecturers in Ergonomics)

# IEA K.U. Smith Student Award

The IEA K.U. Smith Student Award honors two deserving students responsible for applications of or contributions to ergonomics/human factors (E/HF) worthy of recognition. The next awards will be presented during the IEA 2012 Triennial Congress, scheduled to convene February 12-16, 2012, in Recife, Brazil. The Award winners each will receive a cash award of US \$3,000.
